TUITION SCHEDULE:

We are offering three options for tuition payments. **Please circle your choice.**

-Pay 10 month tuition in full by July 1st, 2017.

-Pay half of 10 month tuition by July 1st, 2017, other half by December 1st, 2017.

-Monthly payments of \$700.00

Payments can be made via direct deposit, zelle, check or credit card (cc fees apply). If payment is not received within 5 days of the due date, Mojave Springs School will charge the credit card on file (cc fees apply). The first payment will begin in July.

If you would like to pay via direct deposit we will email you our account and routing number with Bank of America.

Payments will be deducted in July, August, September, October, November, January, February, March and April. There will be no deductions in December 2017, May or June 2018.

\$700.00 of the non-refundable deposit paid upon signing this contract will be used towards 1 month tuition payment. For this reason Mojave Springs School is only deducting payment for nine months if the monthly payment plan is chosen. Non-refundable registration and supply fees still apply.

There is no discount, refund, or other allowance for absence, illness, vacation, holidays, school closures, or any other reason.

1. School operational hours are Monday – Thursday from 8:30am to 3:30pm (with the exception of school holidays listed in the family handbook and other school closures).
2. Tuition, registration fees, supply fees and all other fees are payable directly to Mojave Springs School.
3. Tuition is due the first or fifteenth business day of each month. If tuition does not go through a \$10 fee will be assessed each day beginning on the third business due day of the month until the account is current. During this time children cannot attend school until tuition is paid in full and the account is current. A family whose payment falls behind one week (five business days) will be asked to find other care for their child(ren).
4. Tuition Payments, if not paid in full, will begin July 2017. Tuition payments will be for 10 months.
5. A \$30 fee will be assessed for all NSF checks or other forms of returned payments.
6. I understand and agree that I am financially responsible for tuition and fees for the entire school year, and that tuition and fees are due and payable as indicated on this contract. Should I remove my child(ren) from Mojave Springs School, regardless of the reason, I am still obligated to pay the remaining balance of tuition fees, plus any costs of arbitration and/or collection.
7. Mojave Springs School reserves the right to exclude any child from attendance, temporarily or permanently, under any circumstances deemed in the sole and exclusive discretion of the school to be interfering with the health, safety or educational development of the child or any other child(ren) or whose conduct is unsatisfactory. The school further reserves the right to deny continued enrollment or re-enrollment to any student if the school reasonably concludes that the actions of a parent or guardian are inconsistent or in nonsupport of the educational environment or counterproductive to a positive working relationship between the school and that child's parents or guardians.
8. Mojave Springs School will be on the Clark County School District Schedule. Classes will begin on Monday, August 14th and the last day of classes will be Thursday, May 24th. Classes will run Monday through Thursday. Holidays are Sept 4, Nov 20-24, Dec 25-Jan 5, Jan 15, Feb 15, Feb 19, March 26-Apr 2. This schedule is tentative.
