School operational hours are: Monday – Thursday from 8:30am - 3:00pm for Preschool and Kindergarten
Monday – Friday from 8:30am - 3:00pm for 1st grade *Fridays subject to change
(with the exception of school holidays listed in the family handbook and other school closures)

Tuition, tuition deposit, registration fees, supply fees and all other fees are payable directly to Mojave Springs School.

Tuition is due the 1st or 15th business day of each month. If tuition does not go through a \$10 fee will be charged each day beginning on the third business day of the month after due date until the account is current. During this time children cannot attend school until tuition is paid in full and the account is current. A family whose payment falls behind one week (five business days) will be asked to find other care for their child(ren).

Tuition Payments, if not paid in full, will begin July 2019. Tuition payments will be for 10 months July, Aug, Sept, Oct, Nov, Dec, Jan, Feb, March and April.

There is no discount, refund, or other allowance for absence, illness, vacation, holidays, school closures, or any other reason.

Payments can be made via direct deposit, zelle, check or credit card (cc fees apply 3.5%). If payment is not received within 5 days of the due date, Mojave Springs School will charge the credit card on file (cc fees apply 3.5%). The first payment will begin in July. Credit card must be on file. If you would like to pay via direct deposit we will email you our account and routing number with Bank of America. Payments will be deducted in July, August, September, October, November, December, January, February, March and April. Mojave Springs School will be on the Clark County School District Schedule. Classes will begin on Monday, August 12th, 2019 and the last day of classes will be Wednesday, May 20, 2020. This schedule is tentative.

A \$35 fee will be assessed for all NSF checks or other forms of returned payments. A \$500 administrative fee will apply for all contractual changes made after initial enrollment.

Mojave Springs School reserves the right to exclude any child from attendance, temporarily or permanently, under any circumstances deemed in the sole and exclusive discretion of the school to be interfering with the health, safety or educational development of the child or any other child(ren) or whose conduct is unsatisfactory. The school further reserves the right to deny continued enrollment or re-enrollment to any student if the school reasonably concludes that the actions of a parent or guardian are inconsistent or in nonsupport of the educational environment or counterproductive to a positive working relationship between the school and that child's parents or guardians.

I understand and agree that I am financially responsible for tuition and fees for the entire school year, and that tuition and fees are due and payable as indicated on this contract. Should I remove my child(ren) from Mojave Springs School, regardless of the reason, I am still obligated to pay the remaining balance of tuition fees, plus any costs of arbitration and/or collection.
